



You should read this information guide to help you decide which documents may be useful in supporting the statements that you have made on your visa application form (VAF).

It is not a list of documents that you must submit. We do not expect you to provide all of the documents listed below; it is for you to decide which documents are most relevant to your application.

The submission of all or any of these documents does not guarantee that your application will be successful.

## Guide to supporting documents

Visiting the United Kingdom (UK)

### Information about you

These documents are important because they provide information about your personal circumstances in the country where you are applying.

A current and valid travel document or passport	We will not issue a visa if you do not have a valid passport or travel document to put the visa in.
1 passport-size colour photograph	This must comply with the requirements in our <a href="#">photo guidance</a>
Evidence of your permission to be in the country where you are applying, if you are not a national of that country	This could be a residence permit, 'green card' or valid visa showing your current immigration status.
Previous passports	These are to show your previous travel history
Evidence of your marital status	This could include a marriage certificate, a civil partnership certificate, a divorce certificate or a death certificate
Evidence of your current employment or studies	This could include: <ul style="list-style-type: none"><li>➤ a letter from your employer on company headed paper, detailing your salary and the length of your employment, confirming that you have been given time off work, and stating whether this time off is paid or unpaid. You could also consider submitting further documents which might support an employment letter, such as pay slips or tax returns. If you have recently entered new employment, you could consider providing details of your previous employment and salary history.</li><li>➤ a letter from your education provider on headed paper, confirming your enrolment and leave of absence.</li><li>➤ business registration documents confirming the business owner's name and the date when the business started trading.</li></ul>

### Information about your finances and employment

You may submit any of the following financial documents. You should consider including evidence of your total monthly income from all sources – for example, employment, friends, family, personal savings and property. This will help us assess your circumstances in your own country and will give us evidence of how your trip is to be funded. You should consider providing this information even if someone else is paying for your trip.

- If someone else is paying for your trip, they should consider providing the same information about their finances and employment.
- If you are providing documents from a joint account, please explain who the other account holders are, and why you have permission to spend money from the account.
- If your spouse or partner is employed, the entry clearance officer also finds it helpful to see evidence of their employment and financial details.

Bank statements or bank books	Showing what has been paid in and out of an account for up to the previous 6 months, and naming the account holder. If you have made deposits in your account that are not in keeping with the account history, you might want to explain the origins and timing of these deposits.
Bank letter or balance certificate	Showing the account balance, the account holder's name and the date when the account was opened. If you provide this document, you should consider providing additional documents to show the origins of the money in your account.
Payslips	Covering up to the previous 6 months. If your salary is paid directly into your bank account, you should consider providing the statements showing these payments
Tax returns (business or personal)	You could include recent documents from your government tax office, confirming your income and the amount of tax that you have paid
Business bank account statements	If you include these you may wish to explain why you are allowed to spend the money from a business account if you are on a private visit
Evidence of income from property or land	This could include property deeds, mortgage statements, tenancy agreements, accountant's letters, land registration documents or crop receipts. If the property or land is registered in several names, you may wish to explain how much you own. If the money earned from the land is shared, you may wish to say how it is divided

## Accommodation and travel details

You might want to submit the following documents to help show us your accommodation and travel arrangements in the UK and the date when you intend to leave the UK. We advise that you do not make any payments for accommodation, travel and so on until you have received your visa.

Details of accommodation and return travel bookings	<p>This could be:</p> <ul style="list-style-type: none"> <li>➤ hotel booking confirmation (usually email)</li> <li>➤ travel booking confirmation (can be email or copy of tickets)</li> <li>➤ travel agent confirmation of both</li> <li>➤ accommodation details with a supporting letter from the occupant confirming that you are able to stay there</li> </ul>

## Information about your visit to the UK

Depending on the reason for your visit, you might want to provide some of the following documents to help show us what you plan to do while you are in the UK.

In some locations, you can only apply by making an **online application**. You should check our [list of supported countries](#) to see whether you must or whether you are able to make an online application. If you make an [online application](#), you must also print off the application form and submit it with any supporting documents you have chosen to submit.

### General visitor/tourist

Completed visa application form	If your country does not support online applications, you must complete and submit application form <a href="#">VAF1A</a> .
A planned itinerary, if you have one	This could include: <ul style="list-style-type: none"> <li>➤ bookings or tickets for any excursions, trips and outings</li> <li>➤ email conversations about any excursions, trips and outings</li> <li>➤ travel agent bookings</li> </ul>
Supporting letter(s) from your friend or sponsor in the UK	If you are visiting a friend, you might want to include a letter of invitation from them as well as their financial documents, as outlined in the 'Information about your finances and employment' section above.  You should also consider supplying evidence of their immigration status in the UK. This could be copies of: <ul style="list-style-type: none"> <li>➤ bio-data pages from their passport</li> <li>➤ a valid visa or immigration stamp from their passport</li> <li>➤ a Home Office letter confirming permission to stay in the UK</li> </ul>

### Family visitor

If you want to come to the UK as a family visitor, you should check our [family visitor guidance](#) to ensure that you qualify.

Completed visa application form	If your country does not support online applications, you must complete and submit application form <a href="#">VAF1B</a> .
A planned itinerary, if you have one	This could include: <ul style="list-style-type: none"> <li>➤ bookings or tickets for any excursions, trips and outings</li> <li>➤ email conversations about any excursions, trips and outings</li> <li>➤ travel agent bookings</li> </ul>
Evidence and supporting letter from your family member in the UK that you intend to visit	If you are visiting a family member, you might want to include a letter of invitation from them as well as their financial documents, as outlined in the 'Information about your finances and employment' section above.  You should also consider supplying evidence of their immigration status in the UK. This could be copies of: <ul style="list-style-type: none"> <li>➤ bio-data pages from their passport</li> <li>➤ a valid visa or immigration stamp from their passport</li> <li>➤ a Home Office letter confirming permission to stay in the UK</li> </ul>

### Business visitor

Completed visa application form	If your country does not support online applications, you must complete and submit application form <a href="#">VAF1C</a> (for most types of business visitor).
Evidence of who invited you to the UK	A letter of invitation from the business on their official headed paper confirming who you will be visiting, staying with or supported by during your visit.

Evidence of any previous dealings with the UK company that you are visiting	This could include any evidence of <ul style="list-style-type: none"> <li>➤ business meetings</li> <li>➤ email conversations</li> <li>➤ company activities/ invoices</li> </ul>

### Prospective entrepreneur

This visitor category enables people to come and secure funding in order to set up or run a business in the UK with a view to meeting the Tier 1 (Entrepreneur) financial criteria within 6 months. **This category has specific documentary requirements.**

Completed visa application form	If your country does not support online applications, you must complete and submit application form <a href="#">VAF1C</a> .
Evidence required under the Immigration Rules	You must provide: <ul style="list-style-type: none"> <li>➤ a letter from 1 or more FSA-registered venture capitalists* supporting the application; and/or</li> <li>➤ a letter from 1 or more UK government departments** supporting the application; and/or</li> <li>➤ a letter from 1 or more UK entrepreneurial seed funding competitions which is listed as endorsed on the <a href="#">UK Trade &amp; Investment website</a></li> </ul> <p>* A definition of venture capitalists is on the <a href="#">Business Link website</a>. Venture capitalists must be regulated as venture capitalists by the Financial Services Authority (FSA). See the <a href="#">FSA website</a>.</p> <p>** See the <a href="#">Directgov website</a> for information about UK government departments.</p>
Requirements for letters of support	Each letter must: <ul style="list-style-type: none"> <li>➤ be an original document and not a copy;</li> <li>➤ be on the institution's official headed paper;</li> <li>➤ have been issued and signed by an authorised official of that institution; and</li> <li>➤ have been produced within the 3 months immediately before the date of your visa application</li> </ul> <p>The letter has specific content requirements. To ensure that you meet these requirements, you should read our <a href="#">guidance for prospective entrepreneurs</a> and paragraph 56(O) of the Immigration Rules.</p>

### Student visitor

Completed visa application form	If your country does not support online applications, you must complete and submit application form <a href="#">VAF1D</a> .
Evidence that you have been unconditionally accepted or enrolled on a course of study in the UK	This would normally be a letter of acceptance from the UK educational institution on their official headed paper, providing the following details <ul style="list-style-type: none"> <li>➤ name of the course</li> <li>➤ duration of the course</li> <li>➤ cost of the course (including accommodation if appropriate)</li> </ul>
Evidence of any previous study or qualifications gained	This could be: <ul style="list-style-type: none"> <li>➤ a certificate of award</li> <li>➤ an academic reference or transcript</li> </ul>
Evidence of any English language ability or qualifications	This could be: <ul style="list-style-type: none"> <li>➤ a test result certificate (for example, IELTS, TOEFL or PTE Academic)</li> <li>➤ a certificate of award (for degrees taught in English)</li> </ul>

Evidence of your financial sponsor's occupation, income and any savings or assets they have, as well as any funds they have set aside specifically to pay for your studies	<p>This could include a variety of any of the financial documents outlined in the 'Information about your finances and employment' section above.</p> <p>You should also consider supplying evidence of their immigration status in the UK. This could be copies of:</p> <ul style="list-style-type: none"> <li>➤ bio-data pages from their passport</li> <li>➤ valid visa or immigration stamp from their passport</li> <li>➤ a Home Office letter confirming permission to stay in the UK</li> </ul>
Tuberculosis (TB) testing (where applicable), only for <b>student visitors studying English language courses for longer than 6 months</b>	Residents from <b>some countries</b> applying for a visa to come to the UK for longer than 6 months need to get a certificate confirming that they are free from infectious tuberculosis (TB) before applying for a visa. You can use our <a href="#">country finder</a> to find out whether you need to be tested for TB.

### Academic visitor

Completed visa application form	If your country does not support online applications, you must complete and submit application form <a href="#">VAF1E</a> .
Evidence that you have been invited to the UK by the academic institution you will attend	This could include your formal letter of invitation, confirming what you will be doing at the academic institution and the terms on which you have been invited.
Evidence that you have been working as an academic in an institution of higher education or in the field of your academic expertise immediately prior to your visa application.	<p>This could include evidence of:</p> <ul style="list-style-type: none"> <li>➤ business meetings</li> <li>➤ email conversations</li> <li>➤ company activities</li> <li>➤ employment contract</li> </ul>
Details of any grants or bursaries relevant to your application	This could include documents from the donor on their official headed paper providing details of the bursary or grant that you have been awarded

### Marriage visitor

Completed visa application form	If your country does not support online applications, you must complete and submit application form <a href="#">VAF1E</a> .
Evidence to show that arrangements have been made for the marriage or civil partnership to take place during your visit or if not, that you have given the appropriate notification	<p>This could include:</p> <ul style="list-style-type: none"> <li>➤ evidence that you have given notification of marriage to the registry office in the UK where your partner lives</li> <li>➤ details of the marriage or civil partnership and evidence of money paid towards costs related to it</li> </ul>
Evidence to show that you are free to marry or enter into a civil partnership	<p>This could be:</p> <ul style="list-style-type: none"> <li>➤ a decree nisi</li> <li>➤ a decree absolute</li> <li>➤ a death certificate of a previous partner</li> </ul>

### Medical visitor

Completed visa application form	If your country does not support online applications, you must complete and submit application <a href="#">VAF1G</a> .
Evidence that the hospital or clinic has agreed to treat you	<p>This could include:</p> <ul style="list-style-type: none"> <li>➤ an appointment letter from the hospital detailing the cost and duration of treatment</li> <li>➤ a letter from your consultant</li> </ul>

Evidence to show how the treatment is being paid for	This could include a variety of any of the financial documents outlined above in the finances section

### Visitor in transit and direct airside transit

Completed visa application form	If your country does not support online applications, you must complete and submit: <ul style="list-style-type: none"> <li>➤ application form <a href="#">VAF1H</a> if you are a visitor in transit; or</li> <li>➤ application form <a href="#">VAF6</a> if you are applying for a direct airside transit visa.</li> </ul>
Evidence that the earliest onward passage from the UK has been booked/confirmed, and that it is within 24 hours of arrival in the UK (for direct airside transit) or 48 hours of arrival in the UK (for a visitor in transit)	This could be: <ul style="list-style-type: none"> <li>➤ travel booking confirmation (can be email or copy of tickets)</li> <li>➤ travel agent confirmation</li> </ul>
Evidence that you are assured entry into the onward country that you are travelling to	This could be: <ul style="list-style-type: none"> <li>➤ a residence permit</li> <li>➤ 'green card'</li> <li>➤ valid visa</li> </ul>

### Sports visitor and entertainer visitor

Completed visa application form	If your country does not support online applications, you must complete and submit: <ul style="list-style-type: none"> <li>➤ application form <a href="#">VAF1J</a> if you are a sports visitor; or</li> <li>➤ application form <a href="#">VAF1K</a> if you are an entertainer visitor.</li> </ul>
Evidence of your invitation to attend the event	This would normally be an invitation letter from the organisers of the event on their official headed paper.
Supporting letters from any sponsor's	This could be provided by an official sporting or entertainment organisation, confirming who you will be visiting, staying with or supported by during your visit.

### Olympics/Paralympic Games visit visa

If you are a 'Games family member' who will be travelling to the UK for meetings, training camps and test events outside the period of the Games, you might be eligible to apply for the Olympic/Paralympic Games visit visa. You will be subject to the same controls as other visitors, and if you are a visa national you will need to submit your biometric information and pay the visa application fee as part of your application.

You should also consider submitting supporting documents as detailed in the 'Information about you', 'Information about your finances and employment' and 'Accommodation and travel details' sections above.

Completed visa application form	If your country does not support online applications, you must complete and submit application form <a href="#">VAF1A</a> .
Evidence that you are eligible to apply for a visa under the London Organising Committee for the Olympic and Paralympic Games (LOCOG) scheme	An original letter, or a scanned letter including a unique reference number, from LOCOG confirming that: <ul style="list-style-type: none"> <li>➤ you are eligible to apply for a visa under this scheme;</li> <li>➤ your date of arrival and departure from the UK;</li> <li>➤ your job title and the name of the organisation that you represent; and</li> <li>➤ the name of the person or department at LOCOG that you are visiting or the meeting/workshop/event that you are attending, and how this is specifically relevant to the Olympic or Paralympic Games.</li> </ul> <p>Scanned invitation letters should also contain your passport number.</p>

## Information about children

The UK Border Agency has an obligation under Section 55 of the Borders, Citizenship and Immigration Act 2009 to safeguard the welfare of children. If you apply as a child visitor, we will want to know who your parents are, who you are travelling with, and that there are adequate care arrangements for you in the UK.

If you are an adult (other than the parent or legal guardian) travelling with a child, we might ask you to present the parents' or legal guardian's written consent. If you are the child's parent, you may be asked to provide evidence of the other parent's consent if they are not travelling with you.

The entry clearance officer may wish to see:

- the child's birth certificate
- a signed and dated letter from the child's parent or guardian
- an official letter from an authority confirming guardianship
